SPCA seeks candidates for the board of directors

The Sawgrass Players Club Association's annual meeting will be held on May 28, 2020, at which time homeowners will elect new members to the board of directors to replace current board members William Haley of Water Oak, Ray Navidi of Turtleback Crossing and Marc Stearns of Seven Mile Drive, whose terms are expiring.

within the Sawgrass Players Club. Many of these have included significant hurdles that occur in a system that is more than 30 years old. As the redevelopment portion of the golf course closest to A1A moves forward, the county will be addressing all new challenges in adding new homes to that portion designated as such in the homeowner-approved redevelopment area. All of this will occur under the oversight of the master Architectural Control Committee and OM&W.

Several Sawgrass Players Club communities have tackled the issue of short-term leasing and the threat of AirBnB that has filled the newspapers and nightly news programs throughout the past year. The

Salt Creek community is in the process of following the process completed by Oakbridge, Cypress Creek and others that have amended their guidelines to curtail and prevent rentals under six months. Exceptions have been allowed for rentals during TPC week, which as we all know is the key event in all of Northeast Florida in the spring. Be assured that major companies like Hilton and Marriott have already begun buying properties in our area to be used as short-term property rentals. The master board has requested legal guidance on the proper move to be taken by the Sawgrass Players Club homeowners association in regards to this matter. I urge all homeowners to conduct their own online research; I can assure you will find many articles in

the Wall Street Journal and other news outlets regarding this matter...most not

Avoid late fees; assessments due January 30

Semiannual Sawgrass Players Club Association assessments are due. If you haven't paid yet, you have until Jan. 30 to do so without your account accruing late fees. For those who utilize payment services through your bank or credit card, don't forget to update personal bill pay to the new 2020 assessment amount. You don't need to do anything if you signed up for auto debit of assessments through BBT Association Services. The amount will be updated accordingly.

Beginning in January 2020 the new assessment is \$683.50 due twice a year (in January and July) for a total of \$1,367. The change in assessments is primarily due to increasing costs, the need to accelerate scheduled pump station repairs and replacements, and capital improvements. All homeowners previously received a summarized explanation of the 2020 budget and increases in the mail in mid-November. (See the accompanying summary.)

A large portion of the assessment increase is due to a rise in the required contribution to the general and storm water reserve funds. The cost of asphalt for our roadways is now \$16,300 more than when the last reserve study was completed. An additional \$64,000 will

go to the storm water reserve fund for trash rack replacements at both pump stations along with increasing the size of the discharge pipes to improve our pumping capability prior to and during a major storm.

There is also an increase in overall operating expenses for general repairs and maintenance and waterways. This covers aeration in five ponds and continued pump repairs, along with labor costs to maintain common master-owned elements, including the pool, park, sidewalks and gatehouses. Additional costs are for an independent consultant who has always been utilized to review plans sent to the Operations, Maintenance and Waterways (OMW) Committee. The consultant reviews proposed changes that could potentially impact any of the waterways, such as PGA TOUR plans, Marriott plans, and recently the Animal Clinic expansion near the Bridgewater neighborhood. In 2020 it is expected additional consultant time will be required to review more plans due to development changes, such as the new irrigation pond.

Several residents have asked why they no longer receive email communication from Sawgrass Players Club Association (SPCA). If you have not registered on the new website, you will no longer receive emails. Unfortunately, user logins and email addresses were not able to be transferred from the old website service provider to the new one. Therefore, SPCA no longer has email addresses from the old website.

Each individual resident must register separately on the website using a unique username if they wish to receive emails. Previously, one member of a household could register on the website and enter all family member names and multiple email addresses. This is no longer allowed due to privacy laws to protect gathered personal information.

Salt Creek resident turns tragedy into a book to help kids

Last November, Action News Jax's Tenikka Hughes was in Sawgrass Players Club to interview Salt Creek resident Rhonda Goodall about her new children's book, Where'd Grandma Go?"

The book, written from a child's perspective, documents her youngest son's journey to heal from the sudden, tragic death of his grandmother, Dorothy McCreery. She died in January 2015 when she fell

asleep at the wheel of her car at night and plunged into a lake in Salt Creek just yards from their home. Goodall's mother was trapped in the car as it sunk. She was pulled from the submerged car by firefighters, but later died at the hospital.

At the time Goodall's three boys were ages 16, 13 and 4.

'They all struggled terribly, just in very different ways. My youngest son, Sage,


is whose eyes 'Where'd Grandma Go' is written through, and that's because his difficulty has been more visible,"

said Goodall. "However, my older boys have struggled, silently, to this day. That was just made clear to me as I read an essay that my middle son wrote on a college application.

I sobbed the other day as I read his feelings and what he has dealt with inside. I see the difficulties that

my oldest son struggles with as well."

She hopes the book will help other children who are trying to cope with the loss of a family member.



What's the **big deal** about the pump stations?

Sawgrass Players Club is a 2,400-acre development with a variety of land uses, including residential, golf course and commercial properties. The development lies within a drainage basin that carries rainfall runoff (storm water) to the Atlantic Intracoastal Waterway. The drainage basin is essentially a shallow bowl, much of which was constructed in marsh. The shallow nature of the basin exposes it to storm water flooding as well as hurricane surge flooding from the Intracoastal Waterway.

Two large pump stations — Seven Mile Drive Pump Station and Salt Creek Pump Station — were constructed to reduce the threat of flooding from both sources. Within the basin is a 300-acre system of interconnected features, such as ponds, culverts, weirs and channels that convey stormwater to the pump sta-

tions where the storm water is discharged to the Intracoastal Waterway. The pump stations were designed (along with a perimeter hurricane surge protection berm) to also reduce the chance of hurricane surge encroaching the property.

To ensure maximum property protection, Sawgrass Players Club Association (SPCA) is vigilant about upgrading and properly maintaining the pump stations. The gates at Water Oak and Bermuda Court dam were recently replaced, and the Rio Weir is scheduled for replacement. Other upgrades include installation of a generator and increased pumping capacity at the Seven Mile Drive station.

How do they work? Each pump station has somewhat different pump configurations. Seven Mile Drive Pump Station

is permitted to discharge 98,000 gallons per minute through three pumps driven by interchangeable electric motors or diesel engines to provide more flexibility for dealing with the rainwater. A recently added generator can supply power to one of the electric motors in the case of a power outage. The strategy is to operate the other large pump from the diesel engine.

The smaller capacity Salt Creek Pump Station is permitted to discharge 80,000 gallons per minute through three pumps also driven by interchangeable electric and diesel drives.

During normal operations for typical rain events, sensors in the lakes at the pump stations monitor lake water level and turn the pumps on and off, successively, as the lake water levels rise and fall. If a

major rainfall event is forecasted (such as an approaching tropical storm), under the guidance of the SPCA Storm Water Committee, Marsh Landing Management employees operate the stations manually. If time allows, the pump stations draw down the water levels in the system. Control structures, such as the Rio, Cedar Creek, Bermuda, and Water Oak weirs, have gates, which Marsh Landing Management employees open to drain upstream lakes. You will notice the difference in lake water levels, as more of the banks are visible.

The lake system drawdown creates more storm water storage that helps to reduce the rise of flood water. This gives us a head start on dealing with the rainfall.

No heavy deliveries, construction or gasoline-powered exterior equipment will be allowed through our entry gates.

Over the weekend March 14 – 15, no construction of any nature will be allowed anywhere in the Players Club. Please make sure you call in any in-home service providers and guests in advance.

Nina Court pump station improvements update


The Nina Court Pump Station, located in the Oakbridge community, has been in operation for more than 42 years and is scheduled for a substantial rehabilitation as part of the St. Johns County Utility Department's effort to keep the overall sanitary sewer system operating efficiently. This station is a critical asset in the sewer network due to the size of its large service area.

Located between two residential properties at 106 and 107 Nina Court, the existing site presents multiple challenges regarding access and constructability due to the close proximity to the existing homes. In an effort to mitigate these concerns, Utility staff has been coordinating with the Oak Bridge Golf Course and neighboring residents for several months to explore options to relocate the pump station to a new site. Recent meetings and discussions with adjacent residents, golf course staff, and the developer's representative have provided beneficial feedback for a final site location and landscape screening.

The proposed new site is located in the general area shown on Figure 1 and will be near a proposed berm bordering the future age-restricted development southeast of the site.

The new site would substantially improve facility access and significantly improve utility response time to critical maintenance or repair needs. A key focus of the project is the installation of appropriate landscaping to screen the facility from the proposed public green space and neighboring residents.

A permanent access to the proposed lift station will be from State Road A1A through the future age-restricted community adjacent to the site. This project will also facilitate the decommissioning of aging pipes currently located in easements behind homes along Palmera Drive East, Knotty Pine Trail, Bridgewater Circle and Water Oak Drive. New piping will be installed from the lift station site to A1A and connect to transmission pipes along A1A



Utility staff is currently drafting a location and layout plan based on recent feedback and will be submitting it for review and approval by the golf course developer and the Sawgrass Players Club master association prior to moving forward with the project. The Utility Department has begun the preliminary design of the pump station with the intent to construct the pump station concurrent to the current development

construction activities. Utility staff will provide an update with additional details for the next quarterly publication.

Keep lawn debris out of our waterways

Clumps of grass cuttings. Masses of pine needles. Lots of floating leaves. None of it looks good in our waterways. What's worse, leaves, sticks, grass clippings, etc. contribute to deterioration of our waterway system, and nutrients from fertilizers that enter the water feed the growth of algae blooms.

Homeowners or their landscapers are asked to blow grass clippings up the bank

away from the water. In addition, fertilizers should be sprayed away from water rather than toward it, to prevent wind from picking up some of the product and carrying it toward the water.

Please help keep our waterways clean and clear.

Do not trespass on golf courses

Please remember that the golf courses in our community are privately owned entities. Residents should only be on golf courses if they have a tee time. Walking, biking or other activities are not permitted.

Residents currently trespassing on The Oak Bridge Club golf course is particularly troubling. It is an active construction site. The area is dangerous, particularly in the early evening as it gets dark. There is open trenching as the irrigation system is installed. The homeowners association has received reports of people driving golf carts on the course, fishing in the lakes, walking their dogs on the course and leaving behind dog waste on the cart paths.

The St. Johns County Sheriff's Office has erected "No Trespassing" signs. Please take heed and stay safe.



Bicyclists Take Note!

Safety is everyone's concern.

Controlling lake vegetation and algae is a continuing effort

The cool weather and the new year have arrived and the water temperatures are hovering around 60 degrees. Clear Waters, Inc., crews are working on controlling floating vegetation and isolated algae blooms as they present. Technicians will be continuing to proactively apply the incubated bacteria to algae-prone areas to help break down organic debris on the lake bottoms as well as to the pockets of free-floating Vallisneria (aka eelgrass) to help prevent algal growth.

Beginning this month, Clear Waters will continue to stock grass carp in the areas that currently have the highest concentrations of submersed and floating vegetation. Our technicians are monitoring areas with high concentrations of

Vallisneria for treatment when the water temperatures warm up enough to bring the plants out of their dormant state. We need healthy growing plants for herbicide uptake to achieve optimum results.

Clear Waters, Inc. is looking forward to THE PLAYERS Championship 2020. Our technicians have detailed all shorelines and will continue to maintain into the spring when new growth comes in.

As a friendly reminder, please ask your landscapers to direct grass clippings away from the shorelines and don't allow any fertilizer or pesticides to enter the water.
